ADDENDUM A
BETWEEN CENTRAL ILLINOIS BUILDERS OF AGC AND OTHER EMPLOYERS
AND INTERNATIONAL ASSOCIATION OF BRIDGE, STRUCTURAL AND ORNAMENTAL
IRON WORKERS LOCAL UNION NO. 46

May 1, 2017 to April 30, 2020

The following minimum hourly wage rates shall apply to the classifications as indicated: Structural, Ornamental, Reinforcing, Machinery Mover, Rigger, Machinery Erector, Welder, Fence Erector, Sheeter.

Effective: **05/01/17**
Journeyman..... **\$ 31.29**
Foreman - not less than \$2.00 per hour more than the above listed Journeyman rates.
General Foreman - not less than \$2.30 per hour more than the above listed Journeyman rates.

In addition to the above wage rate the following fringe benefit rate schedule shall apply to all classifications for each hour worked.

Deductions:


1. Dues Check Off.....3.5% of Total Package Paid to the Ironworker
2. International Organizing .25% x \$ 31.29 per hour worked.
3. Effective August 1, 2017, Iron Workers Target Program \$ 0.20 per hour worked.
4. Iron Workers Local 46 Vacation Fund \$ 0.50 per hour worked. Effective August 1, 2017, Iron Workers Vacation Fund \$ 0.68 per hour worked.

Future increases:

Effective May 1, 2018 to April 30, 2019: \$ 1.25 per hour to be distributed plus \$0.02 IAF increase.
Effective May 1, 2019 to April 30, 2020: \$ 1.30 per hour to be distributed plus \$0.02 IAF increase.
