Dear Applicant:

To be eligible for the Ironworkers Apprenticeship Program you must meet the following minimum Qualifications:

1. You must be 18 years of age or older
2. You must have graduated from high school or have a GED.
3. You must provide a copy of a valid driver's license and High School Diploma or GED

During the selection process, extra points will be awarded for a variety of educational experiences. It will improve your chances of being selected into our program if you provide transcripts of your grades for high school and for other courses/classes you may have taken, i.e. vocational and trade school, military, college courses or any other training you may have taken.

If selected for the program, there will be an initiation fee of \$136.75 which will include your 1st month's union dues and \$36.75 per month after that.

Ironwork consists of reinforcing iron, structural iron, ornamental ironwork, bridges, welding, rigging, machinery setting, sheeting, fencing, etc., all of which you must be in good physical condition to do.
